## NOTICE OF PUBLIC HEARING ON PROPOSED ISSUANCE OF MULTI-UNIT HOUSING REVENUE BONDS BY THE NEVADA HOUSING DIVISION

NOTICE IS HEREBY GIVEN that a public hearing pursuant to Section 147(f) of the Internal Revenue Code of 1986 (the "Code") will be held by the Nevada Housing Division (the "Division") as the representative of the State of Nevada (the "State"), on June 29, 2021, beginning at 8:45 a.m. PDT, at the conference rooms of the Division offices, located at the following addresses (and connected via teleconference): 3300 W. The purpose of the hearing is to consider the issuance of up to \$36,000,000 in multi-unit housing revenue bonds of the Division (the "Bonds") and a like amount of refunding obligations, pursuant to a plan of finance, for the acquisition, rehabilitation, and equipping costs of a residential housing rental project located in Clark County at 4485 Pennwood Avenue, Las Vegas, Nevada 89102, containing 232 units of housing to be known as Woodcreek Apartments (the "Project") to be owned by Fairfield Woodcreek NV, LLC, a Nevada limited liability company or another limited partnership or limited liability company sponsored by Fairfield Residential Company LLC (the "Borrower").

THE BONDS WILL BE OBLIGATIONS OF THE DIVISION, PAYABLE SOLELY FROM THE ASSETS OR REVENUES PLEDGED THEREFOR. IN NO EVENT SHALL THE STATE OR ANY POLITICAL SUBDIVISION THEREOF (OTHER THAN THE DIVISION) BE LIABLE ON THE BONDS, AND THE BONDS SHALL NOT CONSTITUTE A DEBT OF THE STATE OR ANY POLITICAL SUBDIVISION THEREOF WITHIN THE MEANING OF ANY CONSTITUTIONAL OR STATUTORY LIMITATION. THE DIVISION HAS NO TAXING POWER.

The Division will, at the above stated time and places, receive written or oral comments and hear all views in favor of or opposed to the proposed issuance of the Bonds or the use of the proceeds of the Bonds, which will be issued to finance the acquisition, rehabilitation and equipping of the above-described Project located in the State for the benefit of the Borrower. Interested persons may, prior to the time of the public hearing, submit their views in writing to the Division by mail to 1830 E. A report of the hearing will be made to the Governor of Nevada, who will consider the issuance of the Bonds for approval for purposes of the Code.
