

**NOTICE OF PUBLIC HEARING ON PROPOSED
ISSUANCE OF SINGLE FAMILY BONDS
BY THE NEVADA HOUSING DIVISION**

NOTICE IS HEREBY GIVEN that a public hearing pursuant to Section 147(f) of the Internal Revenue Code of 1986 (the "Code") will be held by the Nevada Housing Division (the "Division") of the State of Nevada (the "State") on Monday, August 12, 2019, beginning at 8:00 a.m., in the conference rooms of the Division, located at the following addresses (and connected via videoconference):

The purpose of the hearing is to receive public comment on a proposed plan of finance by the Division to issue up to \$122,500,000 of tax-exempt Single Family Mortgage Revenue Bonds, in one or more series and pursuant to one or more indentures, to finance single-family home loans and homebuyer assistance relating to the acquisition of owner-occupied by moderate and low-income persons and families in the State, to refund bonds issued for such purpose, and to pay certain costs of issuing such bonds.

THE BONDS WILL BE AN OBLIGATION OF THE DIVISION PAYABLE FROM THE ASSETS OR REVENUES PLEDGED THEREOF. IN NO EVENT SHALL THE STATE OR ANY POLITICAL SUBDIVISION THEREOF (OTHER THAN THE DIVISION) BE LIABLE ON THE BONDS AND THE BONDS SHALL NOT CONSTITUTE A DEBT OF THE STATE OR ANY POLITICAL SUBDIVISION THEREOF WITHIN THE MEANING OF ANY CONSTITUTIONAL OR STATUTORY LIMITATION. THE DIVISION HAS NO TAXING POWER.

At the above stated time and places, the Division will receive written or oral comments and hear all views regarding the use of the proceeds or issuance of the Bonds. A report of the hearing will be submitted to the Governor of the State, who will consider the issuance of the Bonds for approval for purposes of the Code.

Reasonable efforts will be made to assist and accommodate persons with special needs desiring to attend the hearing.
