Form T4 – Form Instructions

Purpose: Use this form to correct errors on a Certificate of Ownership or related documents.

This form must be submitted with one of the following: Title Form 1 (Certificate of Title Transfer), Certificate of Ownership, MCO, or DRS **and** supporting materials. Do not use this form to request updates to existing records. Fees apply and you can visit the Division's website for the current fee schedule ([Nevada Housing](#)). Submit the completed form promptly after the payment is made.

Step 1: Complete the Form

- Enter: Serial Number of the structure, applicant name and company, email address and phone number. Select preferred contact method.

Section 1 – Related Form

- Select which form the request relates to.

Section 2 – Statement of Error

- Identify section and document containing the error.
- Clearly state:
 - o Incorrect info to remove.
 - o Correct info to add.

Section 3 – Name Correction

- Choose one or more of the following:
 - o **One and the Same Person:** Declare both names refer to the same person.
 - o **Misspelled Name:** Enter correct spelling (must match valid ID).
 - o **Legal Name Change:** List old and new names; state how name should now appear.
- This section includes a legal statement:
 - o Affirms truthfulness.
 - o Accepts responsibility for existing or future claims.

Section 4 – Signature & Notarization

- All current title holders must:
 - o Sign in front of a notary.
 - o Print full legal name(s).
 - o Notary must complete certification and apply stamp/seal.
