# Form T6: Form Instructions

**Purpose:** Use this form to claim ownership of a manufactured structure after the death of the owner, in accordance with NRS 146.080, NRS 134, and NRS 133. Additional forms (e.g., T1) may be required to complete the title transfer.

## Step 1: Complete the Form

### Section 1 – Structure Info

- Enter year, manufacturer, model, serial number, size, and full address.
- Use the Title Search Tool to verify data.

### Section 2 – Value, Property, and Debts

- Initial each statement to confirm:
  - No Nevada real estate was owned by decedent.
  - Property value is under \$25,000 (or \$100,000 if surviving spouse).
  - No probate proceedings exist.

### Section 3 – Claim to Ownership

- Initial each statement to confirm and provide explanation of entitlement:
  - You understand filing a false affidavit is a felony.
  - You are legally entitled based on a will (**NRS 133**) or state succession law (**NRS 134**).
  - Provide your reason and relationship (e.g., “I am the only child”).

### Section 4 – Decedent & Affiant Details

- Provide name and relationship to decedent.
- Indicate % of interest claimed by each affiant.
- State date and location of death.

### Section 5 – Signature & Notarization (Required)

- Wait at least 40 days after death before signing.
- Attach a certified copy of the death certificate.
- Sign in front of a Notary Public. Notary completes stamp and signature.

### Section 6 – County Endorsement (Required)

- County Assessor must sign to confirm current-year taxes are paid.
- **Note:** Starting July 1 each year, endorsements dated before that date will not be accepted.
