Introduction

Per [NRS 319.143](#), the Nevada Housing Division (NHD) maintains a Low-Income Housing Database (LIHD).ⁱ While the LIHD inventory of subsidized affordable housing throughout the State comprises the core of this database, the Division has historically posted additional information to provide supplemental context to the inventory. This information lives on the Division website in the form of supplemental links, reports, and other summaries. With the passage of AB 540 during the 2025 Legislative Session, the Division now compiles this information into an annual report, following the same guidance outlined in [NRS 319.143](#). In addition to this report, archived documentation from prior reporting is available on the “Housing Database” page of the NHD website.ⁱⁱ This document is the first iteration in this new reporting series, and addresses the following LIHD requirements:

1. Assess the affordable housing market at the city and county level, including data relating to housing units, age of housing, rental rates and rental vacancy rates, new home sales and resale of homes, new construction permits, mobile homes, lots available for mobile homes and conversions of multifamily condominiums;
2. Address the housing needs of various population groups in Nevada, such as households that rent, homeowners, elderly households, veterans, persons with disabilities or special needs, homeless persons, recovering persons with a substance use disorder, persons suffering from mental health ailments and victims of domestic violence, with each group distinguished to show the percentage of the population group at different income levels,

and a determination of the number of households within each special-needs group experiencing housing costs greater than 30% of their income, overcrowding or substandard housing;

3. Contain an estimate of the number and condition of subsidized and other low-income housing units at the county level and the identification of any subsidized units that are forecast to convert to market-rate units within a 3-year planning period;
4. Provide a demographic and economic overview by local and county jurisdiction, if feasible, for the population of Nevada, including age, race and ethnicity, household size, migration, current and forecast employment, household income and a summary relating to the effects of demographics and economic factors on housing demand;
5. Provide the number of housing units available to a victim of domestic violence from any housing authority, as defined in NRS 315.021, and from participation in the program of housing assistance pursuant to section 8 of the United States Housing Act of 1937, 42 U.S.C. § 1437f; and
6. Provide the number of terminations of victims of domestic violence in this State from the program of housing assistance pursuant to section 8 of the United States Housing Act of 1937, 42 U.S.C. § 1437f.

Affordable Housing Market Assessment

While the development and housing of residents into affordable, subsidized housing operates differently from the landscape for market-rate housing, certain components with crossover between these areas can provide some insights into the affordable housing market. Selected components for reference within this report include the resale of existing homes and annual authorized construction permits.

Resale of Existing Homes

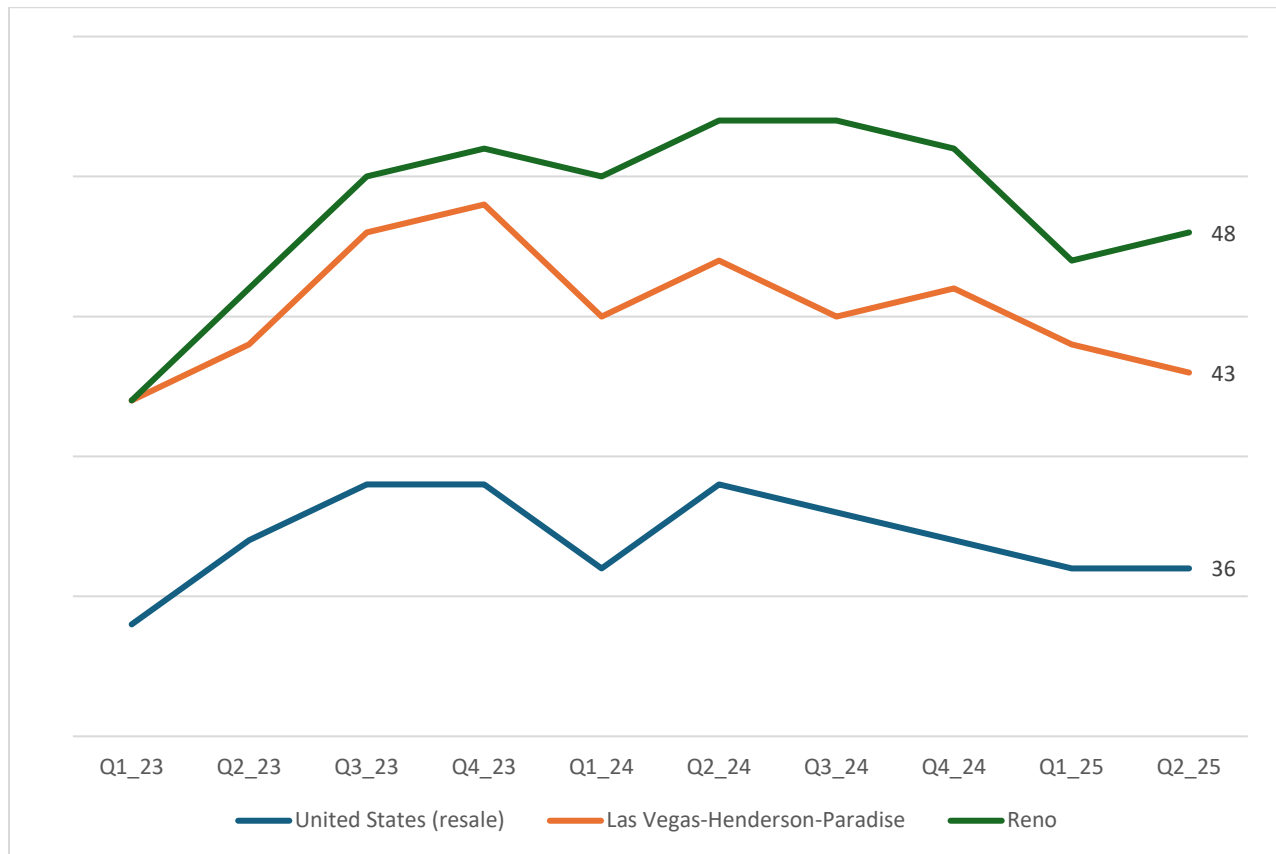
A helpful indicator providing perspective on housing costs is the National Association of Home Builders/Wells Fargo Cost of Housing Index (CHI).ⁱⁱⁱ The CHI is calculated at the national level and metropolitan level (for 175 metropolitan areas) as a ratio of mortgage payment over family income, representing the portion of a typical family's income needed to make a mortgage payment on a median-priced home. The CHI represents an updated version of the previous Housing Opportunity Index (HOI), which ceased production in the First Quarter of 2023.

Table 1 and Figure 1 note the CHI for the United States as well as the Las Vegas-Henderson-Paradise and Reno metropolitan areas from the First Quarter of 2023 (the start of this series) through the Second Quarter of 2025 (the most recent data available at the time of this report publication). Note that Table 1 summarizes the CHI for the resale of existing homes in rows 3-5, as well as the CHI for the sale of new homes (only at the national level) in row 2. Figure 1 only displays data for the resale CHI.

A higher CHI typically denotes decreased affordability. As displayed in Figure 1, households nationwide and in metropolitan subsets of Nevada may be experiencing decreased affordability since the start of this series in 2023, although some softening may be occurring in the nationwide and Las Vegas-Henderson Paradise areas starting near the end of 2024. These indexes are still

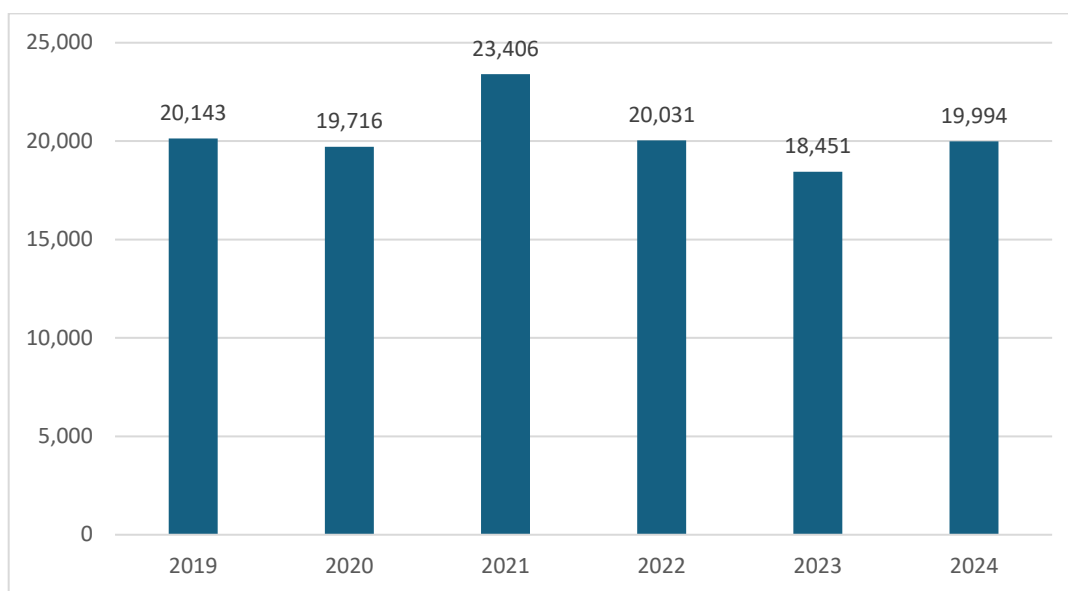
higher than reported in 2023, and there may ultimately be a delay or exclusion of data for Quarters 3 and 4 in 2024 due to impacts from the recent federal government shutdown.

Residential Building Permits

Data on annual building permits authorized can provide additional perspective on how housing needs are being addressed statewide. Specifically, data from the U.S. Census Bureau Residential Building Permits Survey (BPS) can provide insights into the number of new, privately-owned housing units authorized by building permits in the United States.^{iv} Figure 2 displays “current” BPS data (separate from Census Bureau “historical” data^v) on authorized permits for new, privately-owned housing units in Nevada for the years 2019-2024. Permits for all unit counts, ranging from 1 unit (single-family) to over 5 units (multifamily) are included in the figure.

The figure notes some fluctuations in permits year-to-year, ranging from as low as 18,451 permits in 2023 to 23,406 in 2021. While not included in the “current” BPS dataset, data from prior years denotes a persistent decline from greater permitting during the early 2000s, with annual permits in 2003-2005 ranging from 40,000 to nearly 50,000. Further data breakdowns by year (“historical” data from 1995-2019) and geographic location (including State, county, Core-Based Statistical Area or CBSA) are available on the Census Bureau website.^v

Summary of Housing Needs

While the inventory of subsidized housing within the Low-Income Housing Database (LIHD) plays an important role in affordably housing Nevadans, these projects alone cannot currently

meet housing needs throughout the State. Historically, estimates of housing needs—for Nevada and other states—have addressed both the current “gap” of additional housing needed to ensure the supply of available homes meets demand, as well as the needs of residents who are currently housed under inadequate circumstances or conditions. Such conditions may include households who are “cost burdened,” or paying greater than 30% of gross household income on housing costs, or households experiencing physical housing problems, such as challenges with kitchen or plumbing facilities.^{vi} Housing costs generally include gross rent (contract rent plus utilities) for renters and “select monthly owner costs” for owners, which includes mortgage payment, utilities, association fees, insurance, and real estate taxes.

One estimate of need is produced by the National Low-Income Housing Coalition (NLIHC) each year through their annual Gap Report. For this report, the NLIHC uses data from the most recent American Community Survey (ACS) to estimate the availability of affordable rental homes at various income levels for each state in the U.S., the District of Columbia (D.C.), and the 50 largest metropolitan areas. Table 2 summarizes estimates for Nevada from their most recent 2025 report.

In their analysis, the NLIHC notes estimated deficits of affordable and available units, affordable and available units available per 100 households, and estimated households with severe cost burden (paying greater than 50% of gross household income on housing costs) for households at income levels ranging from at or below “Extremely Low Income,” or ELI (incomes below the federal poverty guideline or 30% of AMI, whichever is higher) to 100% AMI, or Area Median Income—the median family income for a region (State, metropolitan area, etc.). Housing deficits and cost burden tend to decline moving from lower to higher income brackets, as households with higher incomes typically have greater housing options. The ELI threshold is an important metric in determining housing need as households at this income level often face the greatest risk of homelessness, and it can be challenging to subsidize housing at this level due to the greater quantity of funding needed to alleviate cost burden. Nevada ranks worst in the Nation for affordable and available units per 100 households at or below ELI with only 17 units available, as noted in Table 2. Not included within the table, but also noted in the Gap Report, is Las Vegas ranking the worst among the 50 largest metropolitan areas for this same metric, with only 13 units available for every 100 extremely-low income households in the area.

Additional estimates of housing need calculated through the U.S. Department of Housing and Urban Development (HUD) Comprehensive Housing Affordability Strategy (CHAS) database

provide additional perspective on needs in the State. Each year, HUD receives custom tabulations of survey data from the U.S. Census Bureau which demonstrate the extent of housing problems and needs throughout the country, especially for low-income households. Included in this data are housing needs estimated by the presence of or more housing problems, including:

1. Incomplete kitchen facilities;
2. Incomplete plumbing facilities;
3. Overcrowding (more than 1 person per room); and
4. Cost burden (general cost burden at 30% of income, or severe cost burden at 50% of income).

The CHAS dataset typically operates on a multi-year lag, and at the time of this report publication the most recent CHAS dataset available is based on data from the 2017-2021 ACS. Table 3 summarizes CHAS data reporting the presence of severe housing problems (Housing Problems One, Two, and Three listed above, and severe cost burden as noted in Housing Problem Four), separated by owner and renter households for incomes ranging from below 30% of the HUD Area Median Family Income (HAMFI), to greater than 100% HAMFI. The HAMFI is HUD's calculation of median family income for each jurisdiction. Table 4 summarizes housing cost burden for these households.^{vii} These tables note that, over the 2017-2021 survey period an estimated 220,350 households in Nevada faced at least one of four Severe Housing Problems, and approximately 172,900 households faced severe cost burden. Note that these tables summarize key information included within the CHAS dataset to estimate housing needs, although additional information in greater detail (i.e. breakdowns by individual housing problems, county estimates) is available through accessing the full CHAS database.

Note that details regarding housing needs of additional population groups are not included in this report due to current data limitations, except for a summary of housing units and assistance available to victims of domestic violence noted in the “Housing Available to Victims of Domestic Violence” section.

Low-Income Housing Database

The Low-Income Housing Database (LIHD) list includes Nevada residential housing that is subsidized at the federal, state, or local level, and which has deed restrictions or other agreements that restrict the income levels of households and/or unit rents, as well as units with associated rental assistance. Included in the total are units with restricted rents and/or restricted income levels, as well as units funded by sources including Low-Income Housing Tax Credits (LIHTC), tax-exempt bonds, and the Home Investment Partnerships Program (HOME).

Also included are units with rental assistance from programs including the USDA Rural Development rental assistance, project-based rental assistance, and various other forms of assistance through the U.S. Department of Housing and Urban Development (HUD) for privately-owned housing. Public housing units as well as non-aided housing owned by public housing authorities are also included, in addition to other low-income housing meeting the specified qualifications. Supportive housing units are included within the total, although transitional housing and group homes are generally not. Additionally, projects undergoing rehabilitation are included, although new projects currently under construction are not.

The LIHD is maintained and updated by the Nevada Housing Division (NHD) through a variety of sources, including in-house Division data as well as outreach with local jurisdictions. The included LIHD is summarized version of the list available on the Division website. The noted summaries in Table 5 and Table 6 are sorted by county and include the following information for each project: total units, restricted units, assisted units, and market rate units. Also included are author tabulations for total units with restrictions or assistance, represented as the difference between total units and market rate units for each project. This calculation is utilized to avoid double-counting as some units may have both restrictions and assistance. The list for this report was prepared on November 26, 2025. As of this date, the LIHD reports 37,987 units with restrictions or assistance across Nevada.

Subsidized Units Forecast to Convert

An additional component tracked by the Division within the LIHD is the timeframe within which subsidized units are forecasted to convert to market-rate units. Subsidized affordable housing projects are commonly subjected to limited timeframes in which units must remain affordable. Once these timeframes have expired, units are no longer bound by affordability restrictions and rents may be increased to market-rate levels. For instance, properties funded with Low-Income Housing Tax Credits (LIHTC) in Nevada generally have affordability periods of 30 years or 50 years once placed in service, contingent upon the type of tax credit received.

Per [NRS 319.143](#), the Division maintains a list of projects with affordability periods expiring within the next three years. The Division also coordinates with local jurisdictions to complete outreach to projects at risk of expiring and ensure compliance with [NRS 319.410](#) to [NRS 319.440](#), inclusive, which requires such projects to report certain information to the Division and local jurisdictions one year in advance of their expiration date.^{viii} This coordination supports efforts to preserve units as affordable housing in Nevada, providing an opportunity for projects to seek additional funding to extend their restricted periods in lieu of these restrictions expiring.

The most recent list, displayed in Table 3, was prepared for this report on November 26, 2025, and summarizes properties with LIHTC and restricted periods anticipated to end within the next three years—in 2026, 2027, or 2028. These dates are approximate and calculated using the credit period start date noted in the Division’s compliance software. Exact dates are available through the Nevada Housing Division LIHTC Compliance Program. As of this date, the LIHD 633 total units with restrictions or assistance at risk of conversion during the upcoming three-year timeframe.

Demographic Overview

While the Nevada Housing Division (NHD) doesn’t currently maintain a demographic database, key demographic information is included for consideration within certain reporting, including the “AB 213 Report on Additional Housing Progress and Plans.” For national population data with certain data subsets—by geographic level (state, county, city, etc.), population components (age, sex, race), and other considerations—the U.S. Census Bureau’s Population Estimates Program (PEP) calculates estimates for time periods as recent as 2024—for annual estimates—at the time of this report. The Nevada State Demographer also calculates similar population estimates and projections for the State. Table 8 utilizes data from the Census Bureau, with tabulations by the author for population change and percentage change, to provide a brief population overview of Nevada, by county, for the time period ranging from 2020-2024. Statewide, Nevada grew nearly five percent during this time period, with Nye County experiencing the largest percentage increase at 7.73% and White Pine County reporting the greatest percentage decrease of -5.84%. Clark County noted the largest population change with an increase of 122,901 residents.

To provide additional demographic context, Table 9 displays employment data compiled from the U.S. Bureau of Labor Statistics (BLS) for the most recent year available at the time of this report, 2024. The table notes data at the county level for total labor force, number of individuals employed and unemployed, and the unemployment rate. The unemployment rate for Nevada has trended historically higher than other states in recent years, and in 2024 Mineral County reported the highest annual average unemployment rate at 9.2%.^{ix}

Housing Available to Victims of Domestic Violence

Some affordable housing subsidies offer targeted support to specific populations in need, such as seniors, veterans, and individuals with disabilities. In addition to these groups, some forms of subsidies offer support to victims of domestic violence. This may include designated unit set-asides or housing assistance through programs such as Housing Choice Vouchers (HCVs, also known as Section 8). Public Housing Authorities (PHAs) administer such vouchers, and Nevada has three PHAs to oversee respective regions throughout the state: the Nevada Rural Housing Authority (NRHA), Reno Housing Authority (RHA), and Southern Nevada Regional Housing Authority (SNRHA).

Correspondence between the Nevada Housing Division (NHD) and PHAs throughout the State in 2020 regarding the number of vouchers and units available to victims of domestic violence is summarized in Table 4.

In addition to this information, PHAs noted that—as of 2020—they did not track data on the number of terminations of Housing Choice Vouchers for victims of domestic violence, although protocols were in place to prevent such terminations. Having these policies helps prevent the termination of housing assistance due to the criminal behavior of a member of a victim’s household or the dissolution of a household due to domestic violence. The Division plans on completing additional outreach with PHAs in 2026 to note any updates as needed to summarized information on housing available to victims of domestic violence.

Conclusion

This report comprises the first iteration of the Division’s updated approach to addressing requirements for the Low-Income Housing Database (LIHD) per [NRS 319.143](#). Included in this report are summaries that are representative, but not fully inclusive, of metrics and components that may be helpful in identifying and addressing housing needs throughout Nevada. Additional annual reports completed by the Division, including the “Annual Housing Progress Report (AHPR),” “AB 213 Report on Additional Housing Progress and Plans,” and other ad-hoc reports also provide supplemental context to the LIHD.
