Supportive Housing, Group Homes and Skilled Nursing Facilities in Nevada

The Nevada Department of Health and Human Services, Division of Public and Behavioral Health Division issues licenses for various types of health facilities. A subset of these licensed facilities provide beds for residential treatment, supportive housing or group homes. The tables below give information about this subset of health facilities, and the number of beds and low income beds available for each Nevada county and type of licensed health facility.
