

**NOTICE OF PUBLIC HEARING ON PROPOSED
ISSUANCE OF MULTI-UNIT HOUSING REVENUE BONDS
BY THE NEVADA HOUSING DIVISION**

NOTICE IS HEREBY GIVEN that a public hearing pursuant to Section 147(f) of the Internal Revenue Code of 1986 (the "Code") will be held by the Nevada Housing Division (the "Division") as the representative of the State of Nevada (the "State"), on August 9, 2018, beginning at 8:30 a.m., at the conference rooms of the Division offices, located at the following addresses (and connected via teleconference): 3300 W. Sahara Avenue, Suite 330, Las Vegas, Nevada 89102; Telephone (702) 486-7220; and 1830 E. College Parkway, Suite 200, Carson City, Nevada 89706; Telephone (775) 687-2240.

The purpose of the hearing is to consider the issuance of up to \$5,000,000 in multi-unit housing revenue bonds or notes of the Division (the "Bonds") pursuant to a plan of finance, for the acquisition, rehabilitation and construction costs of a residential housing rental project located in Nye County at 1000 Erie Main Street, Tonopah, Nevada and containing 56 units of housing for families and seniors (the "Project"). The Project will be known as "Desert Properties Apartments" and will be owned by Desert Properties Associates LLC, a limited liability company, comprised of Desert Properties Manager LLC, as managing member, and the Richman Group Affordable Housing Corporation. The Project will be operated by Weststates Property Management Company.

THE BONDS WILL BE AN OBLIGATION OF THE DIVISION, PAYABLE SOLELY FROM THE ASSETS OR REVENUES PLEDGED THEREFOR. IN NO EVENT SHALL THE STATE OR ANY POLITICAL SUBDIVISION THEREOF (OTHER THAN THE DIVISION) BE LIABLE ON THE BONDS, AND THE BONDS SHALL NOT CONSTITUTE A DEBT OF THE STATE OR ANY POLITICAL SUBDIVISION THEREOF WITHIN THE MEANING OF ANY CONSTITUTIONAL OR STATUTORY LIMITATION. THE DIVISION HAS NO TAXING POWER.

The Division will, at the above stated time and places, receive written or oral comments and hear all views in favor of or opposed to the proposed issuance of the Bonds or the use of the proceeds of the Bonds, which will be issued to finance the acquisition and rehabilitation of the above-described project located in the State. A report of the hearing will be made to the Governor of Nevada, who will consider the issuance of the Bonds for approval for purposes of the Code.

Reasonable efforts will be made to assist and accommodate physically disabled persons desiring to attend the hearing.
